

Competition Standard Terms and Conditions
for
ADM New Zealand Ltd (ADMNZ)

By entering the competition each entrant is deemed to have accepted these terms and conditions and to have agreed to be bound by them.

Failure to supply all requested personal information at the time of submitting an entry, shall render the entry invalid.

Entry is open to New Zealand residents only, who are representatives of an active New Zealand dairy or livestock farming operation, who use Palm Kernel Expeller (PKE) and/or other stockfeed commodities that could be supplied by ADMNZ.

Entries open 830am, 12th June 2019 and close at 5.00pm (CST) 15th June 2019 (the time period). Entries outside of these dates will not be accepted.

All prizes are subject to availability, and ADMNZ reserves the right to replace the prize with an alternative product of equal or higher value if necessary at its sole and absolute discretion.

Entries will be deemed to be void if stolen, forged, or tampered with in any way. ADMNZ reserves the right to refuse to award any prize to an entrant whom ADMNZ decides (in its sole discretion) has violated the Competition Standard Terms and Conditions (The Rules), gained unfair advantage in participating in the competition or won using fraudulent means.
